



GUARANTEED INCOME EVALUATORS

The below information serves as a resource for guaranteed income demonstrations to find experienced evaluators in the field to support their work, as well as connecting guaranteed income evaluations organizations to one another. A single point of contact has been provided for each organization. Please note that the Guaranteed Income Community of Practice (GICP), the GICP co-chairs, and the GICP co-conveners, do not recommend any particular evaluator. We encourage you to speak with other GICP members and evaluators directly to select who may best suit your current programmatic needs.

QUESTIONS TO CONSIDER

When selecting an evaluations partner for your demonstration site, you may wish to consider the following questions:

- What are the deliverables the demonstration site is asking the evaluator to create?
- Over what time frame would the demonstration site require evaluation support, and how does the evaluating organization plan to address continuity in the staff involved both on the program and research end to see the project through?
- What culturally responsive practices will the evaluation organization include in their design process, and how will they ensure these methods are followed? E.g., employing a culturally and skillset diverse team that seeks direction from community stakeholders, and ensuring community respect as experts and not solely research subjects.
- What are the budget constraints of the demonstration program, and can the evaluations organization pivot and design effective research methods to meet these constraints?
- What experience does the evaluator have with the demonstration site's specific region/population served?
- Will there be local on-the-ground staff to work with participants?
- How can the evaluating organization work with the program to mitigate barriers to data collection? E.g., translation services, accessible language for survey participation, building alternatives to mitigate technological barriers, meeting recipients where they may congregate, compensation for participation.
